St Cloud Police: Robbery at Walgreens

On 12/26/14 at 2344 hours Officers responded to the "Walgreens" located at 2505 Division Street West, reference to a robbery that had just occurred. Upon arrival officers determined that an unknown male had entered the store, walked to the front counter, displayed a handgun and demanded cash. The male obtained an undisclosed amount of cash and then fled the store on foot. The suspect was believed to have run north on 25th Avenue and then East on 1st Street North. Officers set up a perimeter and attempted a K9 track however the suspect was not located. No injuries were reported as a result of the robbery.

The suspect was described as a black male, late 40's in age, approximately 5'10" tall, 180-190 lbs. with brown eyes and freckles on his face/cheeks. The suspect was wearing a stocking hat and a black hooded winter jacket that had noticeable gray rectangular patches on the tops of the shoulders and above both breast pockets. The investigation is on-going at this time. Please see the attached surveillance photographs of the suspect taken during the robbery.

On 12/27/14 at approximately 0839 hours officers from the St. Cloud Police Department were sent to a stolen vehicle which had just occurred in the 3000 block of St. Germain Street West. The stolen vehicle was a 2003 Chevy Impala that had been left running with the keys in the ignition. While enroute to the call a St. Cloud Officer observed the stolen vehicle south bound on Cooper Avenue in the 3200 block. The officer immediately observed the stolen vehicle run the stop sign at 33rd street south and strike another vehicle causing the suspect vehicle to roll over. The vehicle that was struck was occupied by two individuals that were not injured in the collision. The lone suspect was then seen to run from the stolen vehicle towards the 1800 Block of Red River Trail. The suspect was described as a white male in his mid-twenties with dark hair and a black jacket.

With the assistance of citizens giving information regarding the direction of the fleeing suspect, officers set up a perimeter and were waiting for a K9 unit when it was discovered that the suspect had entered an unoccupied home in the 1800 block of Red River Trail and had stolen a 2001 Dodge Dakota pickup, maroon in color with a topper, bearing Minnesota license 062NDJ. The vehicle had been observed by officers leaving the area southbound on Cooper. The suspect vehicle ended up crashing through a fence at the end of Cooper Avenue and appeared to have gone off road to I 94 where it is believed that the vehicle was last headed West Bound on I94. Officers from the St. Cloud Police Department were never in pursuit of the vehicle due to the circumstances described above.

At the time of this release the suspect is still at large. The investigation continues into the above series of events to determine the identity of the suspect, and the appropriate number of crimes he will be charged with once he is found.

Officers responded to a report of a robbery in progress in an apartment in the 600 block of 6th Ave South. Officers located 7 victims in an apartment related to this complaint: (4) 18 year old males from St. Cloud, (1) 18 year old female from St. Cloud, (1) 19 year old female from Monticello, and a 21 year old male from St. Cloud.

Investigation revealed that 3 or 4 suspects entered the apartment, displayed firearms, and took several pieces of property from the victims. Through the interviews, it was learned that the suspects also demanded drugs and money that they believed to be present in the apartment.

This information leads police to believe that this was not a random incident, and there is no further threat to public safety. One of the 18 year old males sustained non-life threatening injuries from the incident. Stearns County Sheriff's Department assisted with the initial investigation by utilizing a bloodhound to track the suspects, but the track was not successful. Case is currently active and being investigated by the Campus Area Police.

Upon arrival officers determined that on 07/01/14 at approximately 0330 hours an adult female resident had awoken to three unknown males being inside the residence. It is believed that the suspects entered the residence through an unlocked sliding door. Once the resident discovered the males inside she asked the suspects who they were at which time one of the suspects displayed an item, which may have been a handgun, and demanded money. Suspect #2 was described as a black male, approximately 18-20 years of age standing 5'11" tall with a thin build. The male was wearing an off white colored hooded sweatshirt with gray or khaki colored sweat pants and tennis shoes.

Suspect #3 was described as a black male, approximately 15 years of age standing 5'6" tall with a thin build. The male was wearing a hooded sweatshirt, pants and tennis shoes.

While checking other neighboring residences it did appear that the suspects may have tried to enter two other locations through sliding doors however were unable to gain entrance as the doors were locked.

The St. Cloud Police Department is actively working on this investigation and will have increased patrols and police presence in this neighborhood. The Police Department is asking the public's help regarding any information on the identity of the suspects involved.
