St Cloud Police: Robbery

On 12/07/15 at 1:41 a.m. officers were sent to a robbery that had occurred earlier in the 400 block of 1st Avenue South. Upon arrival officers determined that a 20 year old male victim was outside his apartment sometime between 1:00 a.m. to 1:20 a.m. when he was approached by three unknown male suspects who encircled him. One of the males displayed a knife and ordered the victim to turn over his property. The other suspects then took personal property from the victim after which time they ran to a vehicle and drove away. The victim was not injured during the incident. The victim reported to St. Cloud State University Public Safety who in turn contacted the St. Cloud Police Department.

The suspect vehicle was described as a silver 4 door sedan, possibly a Volkswagon Passot. The male suspect with the knife was described as black male in his mid-20's approximately 6'1" tall with a thick beard around his chin. This male was wearing a red hooded sweatshirt with the hood up and possibly longer hair. The second suspect was described as a black male in his mid-20's approximately 5'10" tall with a heavier build, lighter brown colored hair, and scruffy facial hair. The second suspect was wearing a grey hooded sweatshirt. The third suspect was described only as being a black male that was shorter than the other two suspects and was wearing a hooded sweatshirt (unknown color).

The investigation is actively being worked by the St. Cloud Police Department Campus Area Police Services (CAPS) Unit.

Weapons were not mentioned or observed during the incident. The victims did not sustain any injuries.

The suspect that took the phone was described as a black male approximately 6' tall with shoulder length dreadlock style hair wearing black jeans and a black winter style coat. The other two suspects were described as black males wearing jeans and black hooded sweatshirts.

Benton County Sheriff's Dept: Lottery Scam Targeting Seniors

The Benton County Sheriff's Office has received reports of a check scam circulating through the area. This particular scam appears to be targeting senior citizens. The criminals perpetrating this scam are manufacturing a fraudulent check which is then mailed to senior citizens with a letter telling the victim they have won a lottery. The letter instructs the victim to send money to cover a transaction fee associated with these lottery winnings. The individuals who have called about this letter have not sent any money to the suspects. The checks that have been received by the victims have been verified as forgeries.

Anyone receiving a check with instructions to send money back to the sender should always suspect the check is a forgery. Never send money to someone who contacts you unexpectedly, regardless of the reasons the sender uses for contacting you. Anyone receiving one of these fraudulent checks may contact the Benton County Sheriff's Office.

This is believed to be an isolated incident as no other similar reports have been received.

Benton County Sheriff: IRS Telephone Scam

The Benton County Sheriff's Office would like to remind you to be on guard against telephone and internet scams. On 09/11/2015 the Benton County Sheriff's Office received a complaint from a victim of a telephone scam. The victim received a telephone call from an individual claiming to be associated with the IRS. The scam involved the criminal convincing the victim that there was a warrant for the victim's arrest and that payment was needed right away in order to clear up the matter. Additionally, the criminals in this case are using the non-emergency number of the Benton County Sheriff's Office as their caller ID information. If you are contacted by someone who is asking for money and claiming to be from the IRS or Benton County Sheriff's Office hang up the telephone. The Benton County Sheriff's Office does not and will not call people with arrest warrants asking for money over the telephone. The Benton County Sheriff's Office does not and will not accept credit card payments or pre-paid bank card payments for bail payments.

Citizens should never send money or give personal information to anyone who contacts them unexpectedly over the telephone or internet, regardless of who the person claims to be or how legitimate the person sounds. Citizens should always locate a call back number on their own for the business or agency the person claims to represent and then use this telephone number to verify whether or not this is a legitimate request. 

At 12:38 p.m. the dispatch center received numerous calls regarding multiple gunshots in the area of Central Park located near 29th Avenue North and 4 ½ Street. Officers arrived on scene and located a 33 year old male victim from St. Cloud that had received a non-life threatening gunshot wound. The suspect had left the scene in a vehicle prior to the arrival of the police. The victim was transported to the hospital by Gold Cross for treatment.

Based on initial investigation it is believed that the suspect is known to the victim, and that the earlier fight call was connected to the shots fired call.

Waite Park Police: Assault and Robbery

On 8/5/15 at 10 pm officers received a report of an assault and robbery that had occurred near 10th Ave S. The victim stated he walked from Motel 6 to SA and when he returned to the motel he was approached by a male who had a knife and demanded money. The suspect is described as a white male with long brown hair in a pony tail. The was wearing a dark t-shirt and dark jeans. He is approximately 5'8" and 215 lbs. He is believed to be about 30 years old, with a mustache, goatee and thin beard. He may have also had a tear drop tattoo by his eye.
